

Certification contract

In full use of my faculties, without being subjected to any kind of pressure and as a certified person after demonstrating compliance with the requirements of the certification scheme, established by the Certification Body of People CertMind, I agree and undertake to comply with the following provisions:

- To place the safety and welfare of people above any other consideration, with the commitment to protect public and private property and the environment.

- Not to misuse my status as a certified person, not to use the certification in a misleading or unauthorized manner or develop behaviors that discredit or harm the Certification Body of Persons.

- Not misrepresent, falsify or lie about the scope of the certification obtained, the experience and knowledge I possess or regarding the capabilities of the operation of the equipment or elements for which I obtained the certification.

- Do not falsify or misuse any identification card (card, diploma, etc.), acronyms, logos or any other document of intellectual property of the Certification Body. It is considered improper use when:

- Its content has been altered in any way.
- It is used in situations other than those for which it was granted.
- It is used in a way that discredits the Certification Body.
- It is used in a misleading or unauthorized manner or does not refer exclusively to the type of certification issued by the Certification Body.
- Is used once its validity period has expired or the certification is under suspension.

- Provide accurate, truthful and complete information concerning the certification process; collaborate with any inquiry or administrative investigation of the Certification Body.

- Attend the call for the renewal of certification and submit to the tests provided by the Certification Body for this purpose.

- Accept, when applicable, the suspension or withdrawal of the certification(s) obtained, admitting waiving the rights of use of this from the date on which I am notified in writing of such decision

- In case of renouncing to the certification, misuse of it or prove, by the Certification Body, imprudence, negligence, cause of damage and/or damages during the execution of activities related to the type of certification granted and it is decided to withdraw it, I am obliged to return to the Certification Body the card or diploma received.

- It is not allowed to use the logos of the Certification Body by third parties or entities outside the company. If a third party or external entity needs to use the logos of the Certification Body, they must issue a formal communication to the certifying body explaining the reasons for use, these will be studied by the Certification Body, to issue permission or not to use their logos.

- Not to incur in any cause of document falsification or alteration of certification.

- Notify the Certification Body of any change of address of residence, telephone number or cell phone number of contact or organization where he/she worked, to ensure timely communication for the surveillance and/or renewal process. In case the certified person does not comply with this clause, and it is not possible to locate him/her according to the data provided, the certification will be suspended.

- Not to disclose confidential procedures, requirements, information and examination materials that were involved in the certification process, nor to take part in fraudulent practices.

- I declare that I have accepted the qualification and competency evaluation system of the Certification Body.

- I authorize the Certification Body to release information of the written and practical exams, status of the certification process and/or certificate of competence obtained to designated entities (including state entities), with which I have an employment relationship or that which sponsored my certification process; this except when the law requires non-disclosure.

- Inform the Certification Body of Persons, without delay, on issues that may affect the ability to continue to meet the requirements of certification.

Misuse of the quality of certified person, the card or diploma, or failure to comply with this certification commitment may result in sanctions such as suspension or withdrawal of certification and legal action.
