# Scrum Expert Certified

Our goal at CertMind is to certify the skills of professionals working in the Technology context. To achieve this, we seek to ensure that professionals demonstrate their skills and knowledge through the application of an International Certification Exam.

## Certification category

**Main category:** Scrum Framework

**Subcategory:** Scrum Expert Certified



## Scope of certification


The purpose of the Scrum Expert Certification is to demonstrate that the professional has mastered the structure, considerations and practices for the adoption of Scrum, in addition to demonstrating extensive experience in Scrum-based project management.

## Prerequisites

- Be of legal age, according to the minimum age determined by law (according to the National Identity Card that must be uploaded to the platform).
- Have basic knowledge of reading, writing and basic arithmetic: addition, subtraction, multiplication and division.
- Reading and acceptance of the Code of Ethics available on the platform before taking the certification exam.

## Code of Ethics

All certified professionals must know, accept and abide by the Code of Ethics, which is available for consultation on the platform.



## Certification process and requirements

Professionals interested in obtaining the Scrum Expert Certified (CM-SEC) certification do not need an additional course or exam, because at CertMind we are sure that people learn more when they run experiments and practice with their project teams, therefore, to obtain the Scrum Expert certificate, the following requirements must be met:

1. Be certified as in the Scrum Practitioner (composed of Scrum Fundamentals, Scrum Master, Scrum Developer and Scrum Product Owner) and Scrum Coach (composed of Scrum Team Leader and Scrum Consultant) certification lines.
2. Demonstrate experience of minimum 12 months using Scrum practices, through the application of these in one or more real-world projects of their choice, for this the professional must send evidence of:
  - o Name of the project and description of the project.
  - o Number of people involved.
  - o The duration of the project.
  - o Role occupied by the professional in the project (Allowed roles are Scrum Master, Scrum Product Owner, Scrum Team Leader, Scrum Consultant, Scrum Coach or equivalent).
  - o A description of the work you performed during the project.
  - o Lessons learned and/or conclusions from the application of Scrum.

**Important note :** a letter from the company or client with the above information is acceptable as evidence. The letter must have at least one contact person with whom the information can be validated.

## Certification process and requirements

3. Complete the form you will find on our website with the application form, following the review of the application.
4. The review process can take up to 2 weeks, during this process (when applicable) we will send you comments so that you can improve/change the evidence you sent us.
5. If the application request is denied, you will have up to 4 weeks to correct the evidence, otherwise your process will end here.
6. If the application request is approved, we will generate an invoice corresponding to the certification process that includes: the review of the documents by an expert advisor, an interview with the professional and if applicable, the issuance of the certification as a Scrum Expert and an accreditation letter issued by CertMind attesting to the process applied.

If you are a Scrum Expert, it gives you the possibility to work with us in the construction of new materials, participate in our agile conferences and many more benefits.
